### E. UPDATES

1. Parks and Landscaping Update.

Presented by Landscape Manager, Bill Engelman.

- Clipper Drive There was a delay in January due to rain. Decorative panels are going to be added.

  Decomposed granite and a natural boulder seating element will be added. Information on solar lighting will be available at a future meeting.
- Prop 68 Grant Project Replacing Basketball court and hoops, fixing BBQ and picnic areas, and refurbishing playground surface area at Cornell Park.
- Zone 9 Current project is repairing the concrete fence at Ravenswood Park.

- Zone 35 Looking to add solar lighting on path in-between Newport and Safeway.
- Zone 61 Slifer Park will be getting a new basketball court resurface.

Chair Gutow asked about the lighting situation at the Community Center parking lot. General Manager, Dina Breitstein, reported that an electrical engineer may need to be contacted. Portable lighting may be a short-term solution.

#### 3. Recreation Update.

- Paint Night classes have been ongoing.
- Swim turn and stroke clinic began Monday, February 13, 2023.
- American Red Cross lifeguard class will be available in April.
- Staff is currently hiring lifeguards for the season. Staff will look into using the free tier of advertising with Indeed.
- Several doors were replaced in the Community Center.
- Community Center Project Various service lines were uncovered. Next step is to rewire the irrigation system. Electrical box was fixed.
