- Changing Financial Institutions Q1
 - BAC Bank closed the local branch in Discovery Bay.
 - Management reached out to CSDA to look for other banking options.
 - Currently in the process of changing financial institutions to Five-Star Bank.
 - Earn 0.2% on checking account balances.
 - Money Market Account for dormant cash (currently pays 2.75%).
 - Better online tools and securities.

- Develop and Implement Investment strategy-Q2
 - Working with CSDA to develop an investment strategy to safely investment the District's reserves while optimizing interest earnings.
 - Working with CA Class for investment services.
- Update Rate Study for Water and Wastewater rates-Q2
 - Rate Study expires in June 2025.
 - District can't move forward on pipeline replacement without new rate study
 - Will begin one year early to accommodate pipeline replacement
