The speaker wanted to re-mark lines on the tennis courts. He would like this as a future agenda item.

E. UPDATES

1. Lighting at the Entrance of Discovery Bay Boulevard Update.

Presented by Assistant General Manager Allan Cantando.

- The uplighting at the entrance to Discovery Bay needs replacing. Two quotes were received. Project was quoted at approximately \$12,000- \$13,000.
- There are challenges in replacement due to old electrical wiring.
- · Staff is awaiting a third quote.
- Wall Ball Update.

Presented by Assistant General Manager Allan Cantando.

The Eagle Scouts will begin construction on July 15th.

Public Comment:

- The first speaker asked what type of wood will be used in the project. He stated he had people that
 were willing to contribute funds to the project.
- The second speaker requested to place both tennis and pickleball lines on the wall.

Chair Gutow inquired about the work being done by the Corps on Clipper Drive. He had concerns about the lack of activity. Staff already had plans to address this matter with the Corps.

Chair Gutow requested additional updates. AGM Cantando listed the updates that will be mentioned at the Board of Directors Meeting:

- Townwide palm tree trimming.
- Backflow replacement at Regatta Park.
- Regatta Park playground installation is complete.
- Regatta sign at Regatta and Bixler got permitted through the County.
- Cornell Park work is ongoing.
- Conservation Corps will have two crews working on weeds and streetscape.
- Path from Newport to Safeway will be worked on in the next few days.
- Concrete fencing in Zone 9.

F. DISCUSSION

1. Discussion of Installation of Shade Cover at Community Center Pickleball Court.

Presented by Assistant General Manager Allan Cantando.

- The Pickleball Club would like to install a shade cover at the Pickleball Courts. Shade structure would match the existing shade cover at the site.
- The Pickleball Club will pay for the majority of the project. The Town would cover the additional monies needed to cover prevailing wage.
- Town share would be approximately \$2400.00.
- The Pickleball Club plans to cover the cost of repairs in the future.
- Committee would like to see the project brought to a future Board of Directors Meeting.

Public Comment:

- The first speaker stated she was tired of having to set up the pop-ups at the courts.
- The second speaker questioned why the Boy Scouts can do projects without the same restrictions as the Pickleball Club. Question was referred to legal counsel Andy Pinasco who was attending the meeting online. There was audio difficulty and Legal Counsel Pinasco was unable to answer. General Manager Breitstein will talk with him after the meeting and get an explanation to the Pickleball Club.

Agenda Title:

Discussion and Possible Feedback Regarding the Purchase of a New Lawn Mower for the Parks and Landscape Department.

Recommended Action:

Recommend to the Board of Directors to Authorize the General Manager to execute the purchase/sale agreement with Pape Machinery for a new lawn mower for the Parks and Landscape Department.

Executive Summary:

The Parks and Landscape Department has two lawnmowers in its fleet. The District replaced a mower in June of 2015. Though almost ten years old, this mower is currently working fine. The second mower is the oldest in the fleet and no longer functions efficiently or effectively. The constant repairs have become more costly, and the downtime is adversely affecting the work of the landscaping staff. The landscape and maintenance staff have remarkably kept the mower going far beyond its expected lifespan.

Staff requested multiple quotes for the mower and investigated other purchasing options, such as Omnia Partners Group & Cooperative Purchasing. Only two companies responded with quotes, and Omnia had no mower options. The two quotes are attached to this staff report.

Belkorp AG \$20,322.60 plus 15% contingency for sales tax, freight, set up, and MDF. Pape Machinery \$15,084.4 plus 15% contingency for sales tax, freight, set up, and MDF.

Staff requests the purchase of a new John Deere 72-inch deck mower as a replacement for the old mower.

It is recommended that the Parks and Recreation Committee take the following action:

Recommend to the Board of Directors to Authorize the General Manager to execute the purchase/sale agreement with Pape Machinery for a new lawn mower for the Parks and Landscape Department.
