SUBJECT: Receive Operational Update for January 2014

*This memo summarizes District activities for the month of January.*

Calls for service:

There were a total of 562 service calls in the month of January, with an average response time of 7:04 minutes. In the month of December the District ran 574 calls with an average response time of 6:54 minutes. In the calendar year of 2013, the District ran 6454 calls for service with an average response time of 7:08.

Looking at the response times by stations:

- **Station 52-John Muir Parkway, Brentwood**, had 174 calls in the month of January with an average response time of 6:06 minutes. In December there were a total of 184 calls with an average response time of 6:06 minutes. In the calendar year of 2013 the station ran 1857 calls for service with an average response time of 6:26.
- **Station 54-Downtown Brentwood**, had 106 calls in the month of January with an average response time of 6:30 minutes. In December there were a total of 100 calls with an average response time of 5:54 minutes. In the calendar year of 2013 the station ran 1336 calls for service with an average response time of 6:28.
- **Station 59-1685 Bixler Rd, Discovery Bay**, had 65 calls in the month of January with an average response time of 8:05 minutes. In December there were a total of 66 calls with an average response time of 9:15 minutes. In the calendar year of 2013 the station ran 774 calls for service with an average response time of 8:54.
- **Station 93 530 O'Hare Ave, Oakley**, had 157 calls in the month of January with an average response time of 6:35 minutes. In December there were a total of 161 calls with an average response time of 6:17 minutes. In the calendar year of 2013 the station ran 1752 calls for service with an average response time of 6:16.

- **Station 94-15 A St, Knightsen**, had 11 calls in the month of January with an average response time of 7:44 minutes. In December there were a total of 13 calls with an average response time of 7:38 minutes. In the calendar year of 2013 the station ran 176 calls for service with an average response time of 8:30.
- **Station 95- 3045 Ranch Ln, Bethel Island** (closed 7-1-2012), had 34 calls in the area of this closed station in the month of January with an average response time of 11:29 minutes. In the month of December there were 33 calls with an average response time of 12:02 minutes. In the calendar year of 2013 the District ran 355 calls for service in the station area with an average response time of 11:31.
- **Cal-Fire Station 16-Marsh Creek/Morgan Territory** had 14 calls in the month of January with an average response time of 10:27 minutes. In December there were a total of 17 calls with an average response time of 6:17 minutes. In the calendar year of 2013 the station ran 195 calls for service with an average response time of 9.25.

Auto aid:

In the month of January, the District received auto aid from Contra Costa County Fire 27 times, with them sending 32 engines. The District sent auto aid to Contra Costa County Fire 21 times providing them with 24 engines. During the month of December, Contra Costa County Fire came into the District 30 times with 37 engines and we responded into Contra Costa County Fire 14 times with 14 engines. In 2013, the District received auto aid from Contra Costa County Fire 345 times with them sending 476 engines. The District sent auto aid to Contra Costa County Fire a total of 198 times in 2012, sending 234 engines.

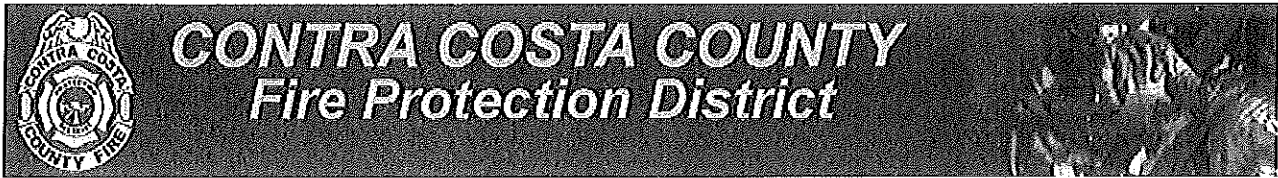
