1. Discussion and Possible Action to Establish an Ad-Hoc Building Construction Oversight Committee to Extend Through the Duration of the New District Office Building Project.

Presented by General Manager Dina Breitstein.

- The Town of Discovery Bay is constructing a new Administration Office Building.
- A team is necessary to effectively manage the project to ensure its successful completion.
- The three components necessary are a design and construction team, construction manager, and an oversight committee.
- The Oversight Committee will be responsible for reviewing and recommending any future building needs to the Board of Directors.

#### Public comment:

- Brian Elliott Brian had questions about the building project. Legal counsel informed speaker about the rules of the Brown Act. He was instructed to look on the website for information from prior meetings.
- Kirk Lawrence Kirk recommended having residents on the Ad Hoc committee.

Director Belcher stated she would like to be considered for the Ad Hoc committee.

Director Porter gave background on the history of the Administrative Office Building.

Director Graves stated this meeting will only be held as needed if at all.

Director Graves made a motion to accept staff recommendation to establish the ad-hoc Building Construction Oversight Committee through the duration of the new District Office Building Project; and establish Director Kevin Graves and Director Ashley Porter to sit on the ad-hoc Construction Management Oversight Committee for the duration of the new District Office Building Project. 2. Discussion and Possible Action to Approve Resolution Number 2025-02 Contra Costa County Local Hazard Mitigation Plan.

- The Contra Costa County Office of Emergency Services (OES) leads the update of the Local Hazard Mitigation Plan (LHMP).
- This plan serves as a guide for the county to become more resilient to the impacts of natural, human-caused, and technological hazards.
- Since January 2023, The Town of Discovery Bay Staff have been collaborating with the Contra Costa County Hazard Mitigation Planning Team to aid in the development of the County-Wide Local Hazard Mitigation Planning process.
- Local governments, including special districts, seeking plan approval are responsible for participating in the planning process and meeting all requirements.

Kirk Lawrence – Kirk commented on the cost of the plan and asked about the benefit.

Vice-President Gutow and President Graham asked General Manager Breitstein to comment on the plan.

General Manager Breitstein stated it took many hours over the last two years to complete. She stated the Town needed to complete their portion in order to qualify for FEMA funding. Each one of the 39 towns, cities and special districts in Contra Costa County must submit for any of them to get any FEMA funding.

Director Graves made a motion to Approve Resolution Number 2025-02 Contra Costa County Local Hazard Mitigation Plan.



# Step 1 – Community Interest & Feasibility Study



- Initial discussions with residents, stakeholders, officials



- Feasibility Study: economic viability, impact on county services, required services and funding

# Step 2 – Petition & Application to LAFCO



- Two ways to initiate: Citizen Petition (25% of voters) or TODB Resolution



- Submission includes feasibility study, governance plan, and service analysis

# Step 3 – LAFCO Review & Public Hearings

- LAFCO evaluates feasibility, land use, and governance structure
- Public hearings for input and modifications
- LAFCO decision: Approve, Modify, or Deny

# Step 4 – Revenue Neutrality Agreement



- Ensures county finances are not negatively impacted



- Revenue-sharing negotiations with the county



- Long-term financial stability of the new city

# Step 5 – Election & Finalization



- Public vote if LAFCO approves



- Requires majority approval (50%+1) of voters



- Finalization by state agencies if approved
